The GFCS - CSP knowledge capture activity is off to a wonderful start with more than 40 promised case studies from a wide range of different organizations. Evaluation

A consortium including USAID, CCAFS, Agrhymet, ICRISAT, and the Mali meteorological department is currently conducting an evaluation of a longstanding agromet service offered by the Mali met department. While Mali's political situation has delayed things a bit, the team is confident that the evaluation will be completed in time to be presented at ICCS 2 in Brussels.

CCAFS also has evaluations planned in India and South Africa. The Red Cross Climate Centre is in the process of planning an evaluation of its collaboration with the IRI. The goal is for all of these to be included in the ICCS 2 agenda.
